Do you want to lower your Indiana State Income Taxes? Through the 2020-2021 Neighborhood Assistance Program from the Indiana Housing and Community Development Authority (IHCDA), Dubois Strong (DS) was allocated \$2080 worth of tax credits in July.

Dubois Strong can double amount (\$4160) by asking for contributions from businesses or individuals who want to help their community and reduce their 2020 State Income tax liability. The money raised is used to provide low income homebuyers down payment assistance or for rent payment assistance. ## **Strategic Plan Update**



Work began on a new strategic plan in June, it had been five years since our last strategic plan was created.

A stakeholder survey was sent out to 200 recipients. The survey focused on the perceived effectiveness and community value of the Dubois Strong organization. With a total of 61 respondents, much of the feedback was positive, but ideas for organizational improvement were also included.

Work continues on fine tuning the new strategic plan. Consultant Tad Dickel presented the draft plan to the full Dubois Strong Board on October 22. Some changes and improvements were suggested by the board.

Next steps include the assignment of timelines and metrics by the new committees which will be formed to help implement the new three-year strategic plan. Implementation of the new strategic plan will begin on January 1, 2021.
